RESOLUTION ADOPTING THE MOORE COUNTY COMPREHENSIVE
TRANSPORTATION PLAN
BY FOXFIRE VILLAGE, NORTH CAROLINA

THE FOXFIRE VILLAGE COUNCIL ORDAINS THAT:

WHEREAS, Foxfire Village has actively participated with Moore County, its other municipalities, and the Triangle Area Rural Planning Organization in the development of a comprehensive transportation plan for Moore County; and

WHEREAS, North Carolina General Statutes 136-66.2 directs the North Carolina Department of Transportation and counties and municipalities to reach agreement for transportation systems that will serve present and anticipated volumes of traffic; and

WHEREAS, Foxfire Village used its 2018-2022 Long Range Plan and its 2016 Land Use Plan to assist and guide its input to, and adoption of, the comprehensive transportation plan; and

WHEREAS, the proposed Moore County comprehensive transportation plan eliminates the widening and use of Roseland Road and Hoffman Road as the proposed Pinehurst Bypass (Western Connector); and

WHEREAS, the comprehensive transportation plan includes a proposal for a Western Truck Route to address the diversion of traffic, particularly truck traffic, to the south and west of Foxfire Village; and

WHEREAS, Foxfire Village stresses the need for all jurisdictions to preserve the proposed corridors of the plan by limiting growth and development in the area of proposed roadways; and

WHEREAS, Foxfire Village encourages the Moore County Transportation Committee to continue to study and seek ways to improve the traffic flow at the Pinehurst traffic circle; and

WHEREAS, Foxfire Village encourages the Moore County Transportation Committee, the county, and its municipalities to ensure that the comprehensive transportation plan is coordinated with land use and development plans to ensure that not only traffic infrastructure is adequate, but that sufficient forest, agricultural, and open spaces are preserved throughout the county to maintain our rural/agricultural character. See Goal# 1 of the current Moore County Land Use Plan

WHEREAS, the proper movement of traffic within and through Foxfire Village and Moore County as a whole is an important element of the comprehensive transportation plan and facilitates orderly growth and development; and

WHEREAS, after analysis of the comprehensive transportation plan and numerous public comment periods, the Foxfire Village Council finds that it is in the best interest of the Village to adopt the Moore County Comprehensive Transportation Plan, specifically that portion of the plan that is within the Village planning jurisdiction pursuant to North Carolina General Statutes 136-66.2.

NOW THEREFORE, BE IT RESOLVED, that Foxfire Village hereby adopts the Moore County Comprehensive Transportation Plan maps, dated May 17, 2018, that are within its planning jurisdiction. This Resolution is hereby submitted to the Triangle Area Rural Planning Organization for endorsement and subsequent action by the North Carolina Board of Transportation.
